Project Overview/Scope: The City of Wheat Ridge is seeking a qualified Armed Security Guard Service for the Municipal Court located at 7500 W. 29th Avenue, Wheat Ridge, CO 80033. The position is responsible for crime detection, screening, crime prevention, and deterrence and control of the entrance and exit of personnel and the general public. Estimated annual work hours of 1,160. Anticipated start date is September 2015. Term is for one year with the option to renew for four (4) one-year renewal periods. Estimated annual budget is \$26,400.00.

Minimum Requirements: Awarded firm must have a valid City of Wheat Ridge Business/Use Tax license prior to starting the project. This service requires compliance with both the "Illegal Alien" provisions of CRS 8-17.5-101 et seq. and "Non-Discrimination Assurance" of Title VI Regulations at 49 CFR Part 21 (forms included in bid documents). Firm must have minimum of five (5) years of experience performing or providing security services of this type. Individuals assigned to the City must have the ability and training to utilize hand-held scanner, baton, oleoresin capsicum spray, hand held radio, walk-through metal detector, x-ray machine, taser, firearm weapon, and handcuffs.

I. INTRODUCTION

A. General

The City of Wheat Ridge (the "City") Municipal Building is located in the northwest Denver metropolitan area, with municipal offices at 7500 W 29th Avenue, Wheat Ridge, CO 80033. The City's area consists of about nine square miles of rolling land adjacent to Interstate 70 transportation corridor between Denver and the Rocky Mountains. The topography is somewhat unique, with a natural ridge traversing the City. The City is a suburban community of approximately 33,000 residents. The City is a home-rule municipality with eight council members, and a city manager and mayor form of government.

B. Background

The City has previously contracted for these services. The agreement will expire this year. Visit the City website for information on multi-year agreements, vendors, and contract expiration dates. The uniformed security guard will be responsible for crime detection, screening, court assistance, prisoner assistance, crime prevention, and deterrence and control of the entrance and exit of personnel and the general public. The primary responsibility is to provide physical security, personnel security, and informational security by using techniques designed to limit or severely curtail the opportunities for successful completion of criminal activities. The security guard must have the ability to relocate moveable walk through metal detector and security scanner at the beginning and end of shift. Metal detector and security scanner has a wheel kit that allows it to be moved in and out of the courtroom.

C. Objectives

The City seeks to contract with a qualified firm to provide armed security guard services from 8:00 A.M. – 5:00 P.M. on Mondays, Wednesdays and the first three Thursdays of each month. Occasional Tuesdays and the 4th and 5th Thursdays from 8:00 A.M. – 5:00 P.M. as needed are for jury trials, excluding holidays. This adds up to approximately 1,160 hours annually. Term shall be for one (1) year with the option to renew for four (4) one-year periods. If the City has never done business with your organization, the initial term may be 6 months or at the sole discretion of the City.

II. STATEMENT OF WORK

The actual services to be performed will be determined by the City, to include but not limited to the following areas:

- Detection, control and seizure of weapons and contraband, drugs, recording devices, cameras, and cell phones.
- Prevention of unauthorized activity by requesting assistance to control, subdue, disarm, or apprehend persons threatening disturbances.
- Prevention of vandalism.
- Prevention and detection of theft, loss, fire, and safety hazards.
- Protection of City equipment and other items or documents.
- Regulation of the direction and flow of the movements of the public.
- Protection of court personnel, attendees, defendants, and witnesses from bodily harm.
- Enforcement of the rules, regulations, and policies related to crime reduction and court operation including assistance with the control of prisoners.

- Courtroom noise reduction.
- Hours: 8:00 A.M. – 5:00 P.M. on Mondays, Wednesdays and the first three Thursdays of each month. Occasional Tuesdays and the 4th and 5th Thursdays from 8:00 A.M. – 5:00 P.M. as needed are for jury trials, excluding holidays.
- Assist Police Officers, Judge, Court Administrator, Court Clerks, Probation Officer, and Court Marshals on an as-needed basis.
- Communication with Police Department, Court Marshal, Presiding Judge, Probation Officer, Court Administrator and court staff.
- Assist visitors and defendants with routine issues and answer general questions.

Requirements:

1. Security firm is required to provide one uniformed guard to perform the duties of guarding and protecting all real and personal property at the Municipal Court of the City of Wheat Ridge.
2. The security firm shall take all the steps necessary to ensure that all guards assigned to this facility have demonstrated security training proficient in the areas pertaining to this project. Annual on-going training is required in areas such as CPR, and firearm qualifying. Oleoresin capsicum spray and taser training are in accordance to agreed industry standards.
3. The security firm must have a minimum of five (5) years of experience performing or providing security services of this type. The security officer assigned by the firm to this project must have a minimum of one (1) year of experience actually engaged in the performance of armed security services. Firm shall conduct all screening exams such as background checks, criminal history, references, etc.
4. Individuals assigned to the City of Wheat Ridge must have the ability and training to utilize hand held scanner, baton, oleoresin capsicum spray, hand held radio, x-ray machine, taser, handcuffs, and a walk through metal detector.
5. The security firm agrees not to allow any person to perform guard services pursuant to this contract, in excess of 12 hours in any 24 hour period unless the work periods are separated by an eight (8) hour non-duty period. This shall include total work hours at other locations or at secondary employment. Further, each guard is to have at least 24 consecutive hours off each week and will normally have two such periods, preferably consecutively.
6. The City may designate a minimum and a maximum total hours per day and per week, per guard, to ensure post familiarity as well as a high level of proficiency.
7. The security firm shall provide all management, supervision, manpower, materials, supplies and equipment (except as otherwise provided). On-site contact and checkup at least once a quarter.
8. The security firm shall provide the City with workers who are free of alcohol and/or drugs. The use of alcohol and/or drugs or narcotics on the job or being under their influence when reporting for work is prohibited and shall be an independent cause for termination or a material breach of the Contract under Article 4 (see attached sample Agreement). Use of prescription and over-the-counter drugs are allowed as long as they do not interfere with an employee's ability to perform the assigned job tasks or duties.
9. CPR certification and firearms qualifications must be submitted annually at the time of renewals.
10. May need to occasionally work after 5:00pm.
11. Must have the ability to confiscate contraband, quiet unruly persons, subdue anyone who might attempt to injure judge or court staff, and remove obstreperous persons from courtroom.

Personnel Standards:

1. Maintain a good working relationship with the local law enforcement personnel, Judge, Court Staff, and the entire criminal justice system with which they have contact.
2. Ability to document and complete required logs and incident report forms as needed.
3. Perform other related work as required or assigned by the Wheat Ridge Municipal Court Administrator and/or the Presiding Judge.
4. Maintain satisfactory standards of competency, conduct, hygiene, cleanliness, appearance, and integrity.
5. Adhere to standards of behavior and appearance that reflect with credit on himself/herself, his/her employer, and the City.
6. All individuals assigned to the City of Wheat Ridge must meet the following minimum standards:
 - A. 21 years or older.
 - B. Able to read, write, and speak the English language fluently.
 - C. High school education or equivalency.

- D. Ability to meet and deal with the general public.
- E. Ability to make written or verbal reports of his/her activities readily understandable to supervisors.
- F. Ability to read, understand, and apply written rules, detailed orders, instructions and training materials.
- G. Ability to maintain poise and self-control under stress.
- H. No felony convictions, conviction of any misdemeanor which, in the judgment of the City reflects unfavorably on his/her fitness. (By mutual agreement permission is granted by the security firm and the individuals assigned to the City of Wheat Ridge that background checks may be made by the City of Wheat Ridge Police Department, including polygraph examination.)
- I. Possess a valid Colorado Driver's License.
- J. Shall possess binocular vision, correctable to 20/20 (Snellen) and shall not be color blind.
- K. Capable of hearing ordinary conversation at 20 feet and whispered conversation at 10 feet.
- L. Push/pull 180 pounds.
- M. Able to sit, stand and walk for extended periods.

Not meeting the minimum standards shall be considered justification for replacement. Any of the following will also be considered justification for replacement:

- A. Conviction of any felony, conviction of any misdemeanor with, in the judgment of the City, reflects unfavorably on his/her fitness.
- B. Suspension or revocation of a Colorado Driver's License.
- C. Formally charged with a criminal offense, the nature of which may make him/her unable to meet the minimum qualifications.
- D. Neglect of duty, which includes but is in no way limited to: sleeping while on duty, unreasonable delays or failure to carry out assigned tasks, conducting personal affairs during official time, and refusing to render assistance or cooperation in upholding the integrity of the security program.
- E. Falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records, or concealment of material facts by willful omissions from official documents or records.
- F. Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words or actions, or fighting.
- G. Participation in disruptive activities which interfere with the normal efficient operations of the City.
- H. Theft, vandalism, or any other criminal actions.
- I. Selling, consuming or being under the influence of intoxicants, drugs or other substances which produce similar effects. (By mutual agreement the security firm, individuals assigned to the City of Wheat Ridge, and the City may conduct immediate drug screenings of any assigned individuals to the security guard position.)
- J. Improper use of official authority or credentials.
- K. Unauthorized use of communication equipment or City property.
- L. Violation of security procedures and regulations.
- M. Engaging in any other such activity which, in the city's opinion, may constitute improper conduct or dereliction of assigned duties.
- N. Demonstrate proficiency in the use of Firearm, taser, handcuffs, wand, magnetometer, x-ray, training, and operation.

Training Requirements:

1. The City will provide initial orientation of the site and familiarization with general operating rules. The supervisor shall be responsible for orienting all guard personnel including any replacement personnel.
2. Guards on their first assignment at the City shall be oriented and instructed by a supervisor of the firm before commencing their tour of duty. Instruction shall be sufficiently comprehensive so that guards may effectively and efficiently perform the duties required.
3. "Supervised on-the-job training" means that personnel receive close observation and supervision. Merely being assigned to a job will not be considered on-the-job training.
4. The City may require evidence of satisfactory completion of required training for all guard personnel assigned to the City.
5. All expenses associated with training personnel shall be borne by and be the sole responsibility of the security firm.
6. Training of replacement personnel will be identical to the initial guard service training and the expense thereof shall be the sole responsibility of the security firm.

7. The City may waive training requirements if the training and the experience of the prospective personnel is such that the City deems that further training is unnecessary. Any such waiver must be requested in writing by the security firm, for approval by the Presiding Judge or the Court Administrator.
8. Presiding Judge or Court Administrator will review standing court security orders with guard.

IN NO INSTANCE WILL THE GUARD ACT IN THE CAPACITY OF A POLICE OFFICER AND THE POWER OF ARREST WILL BE LIMITED TO THAT OF A PRIVATE CITIZEN. In the event of any criminal activity or arrest, immediate notification of the Wheat Ridge Police and Court Marshal shall be accomplished through direct contact. The City will provide a hand held radio to the assigned guard personnel to directly communicate with the Wheat Ridge Police Department.

The security guard assigned to the City of Wheat Ridge is expected to freely cooperate with Police action and reporting requirements which include submitting detailed statements and accurate testimony associated with initiated police activity.

B. Evaluation Criteria

To simplify the review process and to obtain the maximum degree of comparability, the proposal must follow the outline described below and at a minimum contain the requested information.

Firms will be judged not only on their past experience for the type of work involved, but also on their ability to address issues critical to the success of the project requirements outlined in this RFP. Submittals should be formatted to correspond exactly to the bullets. Indexes for each of the categories are preferred, in the same order. Additional relevant information is encouraged, though proposals should not exceed 75 letter-sized pages in length.

Omissions or incomplete responses in terms of content or aberrations in form may, at the City's discretion, render the proposal non-responsive. 2) Qualifications of the Firm (20%)

- a. Provide an overview of your company's history. Include information on management, firm size, number of employees, years in business, and location of working office.
- b. Provide references: include the name, current phone number, email address and a summary of similar services provided listing a minimum of three (3) current or within the past three (3) years references. Include any supplemental references or qualifications that may attest to your firm's current ability to provide the required services.
- c. Provide a statement agreeing to provide and maintain insurance per the RFP requirements, if awarded.

3) Experience of Staff and Team (30%)

- a. Provide resumes of guards and supervisors assigned to perform services for this project.
- b. Describe individual experiences with the City or other government agencies.
- c. Include experiences in the Denver Metropolitan and Colorado areas.
- d. Provide any unique strengths or experiences.
- e. Detail your training and certification programs: CPR, x-ray scanner, magnetometer, firearm qualifying programs, sprays and tasers.

4) Approach, Timelines, and Current Workload (20%)

- a. Provide information on current workload.
- b. Detail your approach and length on how you plan to accomplish the initial training/orientation prior to starting, i.e. familiarity of the building, general operating rules, procedures, etc.
- c. Identify any foreseeable problems in the implementation of the program
- d. Describe how the objectives identified will be achieved
- e. Detail any recycle, sustainable or greening efforts by your firm
- f. Detail a list of what portion of the work, if any, will be subcontracted.

5) Fee Schedule (30%)

- a. Provide an all inclusive individual hourly rate.
- b. List any other costs, if applicable.
- c. Value added services
- d. Rates are negotiable

The City reserves the right to base its evaluation on a "Should Cost" analysis to reflect the real costs to the City arising out of, or incidental to the award. The City shall look to substance more than format and shall perform its cost and price evaluation on the basis of probable real costs.

IV. SELECTION PROCESS

The selection committee may either recommend an award based on the proposals alone, or elect to short-list firms and conduct interviews. The short-list process includes written notification to the short-listed firms, interviews with firm members, reference checks on the top-ranked firm, and the negotiation of fees.

- 1) **Short List:** Submittals will be evaluated in accordance with the evaluation criteria above. The panel will review and score all proposals received. Firms with the highest scores may be invited to participate in oral interviews with the evaluation committee.
- 2) **Oral Interviews:** It is anticipated that oral interviews will be conducted in accordance to the schedule below. Short-listed firms will be notified in writing and invited to interview. Key personnel from the firm and major consultants who will be directly involved with the project should attend the interview. The selection committee will, in particular, be interested in knowing more about the firm's previous experiences, the

perceived ability to meet specified deadlines, and the overall project approach, and will appreciate the opportunity to converse with individuals who will act as the primary contacts for the project.

- 3) **Fee Proposals and Final Selection:** The City will attempt to negotiate a contract with the highest ranked firm, following the interview process.

VI. ADMINISTRATIVE AND OFFEROR INFORMATION

1) **PROPOSAL OPENING, EVALUATION, AND AWARD**

There is no public opening. Names of each proposer will be posted on the city website. Proposals will be examined after opening, and will be evaluated on the basis of the evaluation criteria. The firm selected for the award will be chosen on the basis of the apparent greatest benefit to the City and not necessarily on the basis of lowest price. The City reserves the right to make multiple awards if deemed in the best interest of the City. No proposal may be withdrawn for a period of sixty (60) calendar days of the Proposal Opening date.

2) **SALES AND USE TAXES**

Don't include sales or use tax in your proposal, as the City of Wheat Ridge is exempt from City, County, State, and Federal sales and excise taxes. Certificates will be issued upon request.

3) **PROPOSER QUALIFICATIONS**

No proposal shall be accepted from and no contract will be awarded to any person, firm, or corporation that is in arrears to the City of Wheat Ridge, upon debt or contract that is a defaulter, as surety or otherwise, upon any obligation to the City, or that is deemed irresponsible or unreliable by the City. If requested, proposers shall be required to submit satisfactory evidence that they have a practical knowledge of the particular supply or service bid upon and that they have the necessary financial resources to provide the proposed supply or service.

4) **RIGHT TO INVESTIGATE**

The City reserves the right to investigate and confirm the proposer's financial responsibility. This may include financial statements, bank references, and interview with past consultants, employees, and creditors. Unfavorable responses to these investigations are grounds for rejection of the proposal.

5) **NO COMMITMENT BY THE CITY OF WHEAT RIDGE**

This Request for Proposals does not commit the City of Wheat Ridge to award any costs or to pay any costs, or to award any contract, or to pay any costs associated with or incurred in the preparation of a proposal to this request, or to procure or contract for services or supplies. In acceptance of proposals, the City of Wheat Ridge reserves the right to negotiate further with one or more of the contractors as to any

features of their proposals, and to accept modifications of the work and price when such action will be in the best interest of the City. This includes solicitation of a best and final offer from one or more of the proposers.

6) **PROPOSAL REPRESENTATION**

Each proposer must sign the proposal and shall give his or her full business address on the form provided in this proposal. Proposals by partnerships shall be signed with the partnership name by one of the members or by an authorized representative. Proposals by corporations shall be signed with the name of the corporation, followed by the signature and designation of the president, secretary, or other person authorized to bind it in the matter and shall have the corporate seal affixed thereto.

7) **ANTI COLLUSION CLAUSE**

No officer or employee of the City of Wheat Ridge, and no other public official or employee who may exercise any function or responsibilities in the review or approval of this undertaking, shall have any personal or financial interest—direct or indirect—in any contract or negotiation process thereof. The above compliance request will be part of all City of Wheat Ridge contracts for this service.

8) **INSURANCE**

The successful proposer shall, during the term of this Agreement and until completion thereof, provide and maintain the following types and minimum insurance coverage, as follows:

The successful proposer shall effect the insurance policies in a company or companies and in a form satisfactory to the Owner. Before commencing any performance under the Agreement, successful proposer shall deliver to the City certificates of insurance issued by the insurance company and/or its duly authorized agents, pertaining to the aforementioned insurance and certifying that the policies stipulated above are in full force and effect.

Nothing herein shall be deemed or construed as a waiver of any of the protections to which the Agencies may be entitled pursuant to the Colorado Governmental Immunity Act, sections 24-10-101, C.R.S., as amended.

Workers' Compensation Insurance

The contractor shall provide workers' compensation insurance for all persons employed to perform work to be done under the contract, and assure that all workers will receive compensation for compensable injuries.

9) **LAWS AND REGULATIONS**

All applicable State of Colorado and Federal laws, City and County ordinances, licenses and regulations shall apply to the award throughout, and herein incorporated here by reference.

10) **SUBCONTRACTING**

No portion of this proposal may be subcontracted without the prior written approval of the City.

11) **SALES PROHIBITED / CONFLICT OF INTEREST**

No officer, employee, or member of City Council shall have a financial interest in the sale to the City of any real or personal property, equipment, material, supplies, or services—where such officer or employee exercises (directly or indirectly) any decision-making authority concerning such sale, or has any supervisory authority over the services to be rendered. Soliciting or accepting any gift, gratuity favor, entertainment, kickback, or any items of monetary value from any person who has or is seeking to do business with the City of Wheat Ridge is prohibited.

12) **MODIFICATION OF AGREEMENT**

No modification of award shall be binding upon the City, unless made in writing and signed by authorized agents of both parties.

13) **CANCELLATION**

Either party may cancel the award in the event that a petition—either voluntary or involuntary—is filed to declare the other party bankrupt or insolvent, or in the event that such party makes an assignment for the benefit of creditors.

14) **TERMINATION OF AWARD FOR CAUSE**

If through any cause the successful proposer shall fail to fulfill in a timely and proper manner its obligations, or if the successful proposer shall violate any of the covenants, agreements, or stipulations of the award, the City shall thereupon have the right to terminate the award by giving written notice to the successful proposer of such termination—specifying the effective date of termination. In that event, all finished or unfinished services, reports, or other materials prepared by the successful proposer shall—at the option of the City—become its property, and the successful proposer shall be entitled to receive just, equitable compensation for any satisfactory work completed, or prepared documents/materials furnished.

Notwithstanding the above, the successful proposer shall not be relieved of liability to the City for damage sustained by the City by virtue of breach of the award by the successful proposer, and the City may withhold any payments to the successful vendor for the purpose of set-off, until such time as the exact amount of damages due the City from the successful proposer is determined.

15) **TERMINATION OF AWARD FOR CONVENIENCE**

The City may terminate the award at any time by giving written notice to the successful vendor of such termination (specifying the effective date thereof) at least thirty (30) working days before the effective date of such termination. In that event all finished or unfinished services, reports, materials(s) prepared or furnished by the successful proposer under the award shall—at the option of the City—become its property.

If the award is terminated by the City as provided herein, the successful vendor will be paid an amount which bears the same ratio to the total compensation as the services actually performed or material of compensation previously made. If the award is terminated due to the fault of the successful proposer, termination of award for cause relative to termination shall apply.

16) **EQUAL OPPORTUNITY**

The successful firm will agree not to refuse to hire, discharge, promote, demote, or to otherwise discriminate in matters of compensation against any person otherwise qualified solely because of race, creed, sex, national origin, ancestry, or physical handicap.

It shall be a condition that any company, firm, or corporation supplying goods or services must be in compliance with the appropriate areas of the Americans with Disabilities Act of 1990 as enacted, and from time to time amended, and any other applicable Federal regulation. A signed, written certificate stating compliance with the Americans with Disabilities Act may be required, upon request, by the City.

18) **COMMON LANGUAGE**

Unless otherwise specified in this document, all words shall have a common language unless the context in which they are used clearly requires a different meaning. Additionally, words in the masculine gender include the feminine and the neuter, and when the sense so indicates, words of the neuter gender may refer to any gender. The words "firm," "bidder," "vendor," "contractor," "consultant," and "proposer" refer to any person, partnership, corporation, or other entity.

19) **PROPRIETARY INFORMATION**

The evaluation committee will hold information provided by proposers during the RFP process in confidence until the date of an award. After that date, proposals will become public record. Proposers may request parts of their proposals to remain confidential and shall indicate as such in the proposal and on the appropriate proprietary or financial pages. All information included in any proposal that is of a proprietary nature must be **clearly** marked. Attempts by proposers to establish informal communication channels regarding this procurement will be viewed negatively, and shall result in rejection of the offending firm's offer.

21) **PROPOSAL FORMAT**

All responses to this Request for Proposal shall use the respondent's format, except for those pages which have blanks to be filled in by the respondent, or those pages marked for return with proposal. A proposal can be rejected by the City if the submitting firm fails to completely fill in all blanks for evaluation of the proposal, or fails to answer all questions. Proposal should be submitted initially on the most favorable terms. All proposals shall be prepared in a comprehensive manner as to content; however, no necessity exists for expensive binders or promotional materials. All costs—including travel and expenses incurred in the preparation of this proposal—shall be borne solely by the proposer.

22) **PROPOSAL REJECTION AND / OR PARTIAL ACCEPTANCE**

The City reserves the right to the following:

- Reject any and all proposals.
- Accept other than the lowest price.
- Waive minor defects or technicalities, formalities, and informalities.
- Accept in whole or in part such proposal where it is deemed advisable.
- Make an award on the basis of the apparent greatest benefit to the City of Wheat Ridge.
- Alter the scope of work reasonably and RFP documents until a contract is executed.

23) **GOVERNING LAW**

The laws of the State of Colorado shall govern any contract executed between the successful contractor and the City. Further, the place of performance and transaction of business shall be deemed to be in the County of Jefferson, State of Colorado. In the event of litigation, the exclusive venue and place of jurisdiction shall be the State of Colorado—more specifically, Jefferson County, Colorado.

24) **TAXES AND LICENSES BY THE AWARDED CONTRACTOR**

The contractor shall promptly pay—when they are due—all taxes, excises, license fees, and permit fees of whatever nature applicable to work which it performs under this agreement, and shall take out and keep current all required municipal, County, State or Federal licenses required to perform this work. Additionally, the contractor shall furnish the City—upon request—duplicate receipts or other satisfactory evidence showing or certifying to the proper payment of all required licenses and taxes. Contractor shall promptly pay—when due—all bills, debts, and obligations it incurs performing work under this agreement, and to allow no lien, mortgage, judgment, or execution to be filed against land, facilities, or improvements owned by the City.

25) **PROMPT PAYMENT DISCOUNTS**

Prompt payment discounts allowing less than 10 days for the discount to apply shall not be considered as a cost factor in the evaluation of proposals. In connection with any prompt payment discount offered, time will be computed from date of receipt of a correct invoice to include the receipt and acceptance of performance.

26) **OWNERSHIP OF CONTRACT PRODUCTS**

All products produced from the awarded contract shall be the sole property of the City.

27) **FUNDING**

The awarded firm shall employ only competent persons to do the work, and whenever requested in writing by the City Representative, the firm shall discharge any person who commits trespass or in, in the opinion of the City Representative, disorderly, dangerous, unfaithful, insubordinate, incompetent or otherwise unsatisfactory.

32) **DEBRIEFING**

After the project award has been made, vendors may contact the City Purchasing Agent to request a debriefing on the selection process, as well as a discussion of the strengths and weaknesses of their firm's proposal.

33) **SECURITY ACCESS CARDS**

The City will issue security access cards to assigned workers. It will be at the discretion of the City to determine if the access cards are issued specifically for each worker, or if a guest card will be issued.

WITNESSETH, that the City of Wheat Ridge and the Contractor agree as follows:

ARTICLE 1 – SERVICES

The Contractor shall serve as the City’s contractor and provide as a minimum all of the professional services required as per **RFP-15-21 ARMED GUARD SERVICES**, as more fully described in the Request for Proposal and Contractor’s response to the RFP (Exhibit 1) incorporated herein by reference.

ARTICLE 2 – TERM

The work to be performed under this agreement shall commence promptly after receipt of a fully-executed copy of the agreement, to the extent that the Contractor has been authorized to proceed by the City.

THE TERM FOR THIS AGREEMENT IS THROUGH MONTH, DATE, YEAR, WITH THE OPTION TO RENEW FOR FOUR (4) ADDITIONAL ONE-YEAR PERIODS, AT THE SOLE DISCRETION OF THE CITY. If your firm has never performed work for the City, the initial term of the agreement may be six (6) months, at the sole discretion of the City.

At the end of each year, if the City deems the Contractor’s performance is acceptable and the pricing remains the same, the agreement may continue with automatic renewals. The agreement may be automatically renewed if:

- The City fails to contact your firm prior to the end of the current term regarding the desire to renew.
- All pricing remains the same.

The contractor is specifically advised of the provisions of this portion of the Code of Laws of the City of Wheat Ridge, which was enacted pursuant to Ordinance 787, Series of 1989, and expressly incorporated herein. This contract is specifically subject to the provisions of said Ordinance and adopted Code Section.

ARTICLE 4 – INDEPENDENT CONTRACTOR

In performing the work under this agreement, the Contractor acts as an independent contractor and is solely responsible for necessary and adequate worker's compensation insurance, personal injury and property damage insurance, as well errors and omissions insurance. The Contractor, as an independent contractor, is obligated to pay Federal and State income tax on monies earned. The personnel employed by the Contractor are not and shall not become employees, agents, or servants of the City because of the performance of any work by this agreement. The Contractor shall not discriminate against any employee or applicant for employment because of age, race, color, religion, sex, or national origin. The Contractor shall adhere to acceptable affirmative action guidelines in selecting employees and shall ensure that employees are treated equally during employment, without regard to age, race, color, religion, sex, or national origin. Such action shall include—but not be limited to the following: employment, upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation, and selection for training—including apprenticeship. ARTICLE 11 – TERMINATION

The Contractor acknowledges that his failure to accomplish the work as described shall be considered a material breach of the contract and entitle the City to consequential damages resulting from failures, acts, or omissions—including, but not limited to re-procurement costs, insufficient or improper work.

The City and the Contractor agree that this agreement may be canceled for cause by either party, with a fifteen (15) day prior written notice. ARTICLE 13 – ASSIGNMENT AND SUBCONTRACTORS

The duties and obligations of the Contractor arising hereunder cannot be assigned, delegated, nor subcontracted except with the express written consent of the City. The subcontractors permitted by the City shall be subject to the requirements of this agreement, and the contractor is responsible for all subcontracting arrangements, as well as the delivery of services as set forth in this agreement. The contractor shall be responsible for the performance of any subcontractor.

ARTICLE 14 – SEVERABILITY

To the extent that the agreement may be executed and performance of the obligations of the parties may be accomplished within the intent of the agreement, the terms of this agreement are severable. Should any term or provision hereof be declared invalid or become inoperative for any reason, such invalidity or failure shall not affect the validity of any other term or provision hereof. The waiver of any breach of a term hereof shall not be construed as a waiver of any other term, or the same term upon subsequent breach.

ARTICLE 15 – INTEGRATION OF UNDERSTANDINGS

This agreement is intended as the complete integration of all understanding between the parties. No prior or contemporaneous addition, deletion, or other amendment hereto shall have any force and effect whatsoever, unless embodied herein in writing. No subsequent novation, renewal, addition, deletion, or other amendment hereto shall have any force or effect unless embodied in writing and signed by an authorized representative of the City and the contractor.

ARTICLE 16 – PROHIBITION ON EMPLOYING OR CONTRATING WITH ILLEGAL ALIENS

Illegal Aliens – Public Contracts for Services

CRS 8-17.5-101 and Public Law 208, 104th Congress, as amended and expanded in Public Law 156, 108th Congress, as amended:

The Contactor certifies that he/she shall comply with the provisions of CRS 8-17.5-101 et seq. The Contractor shall not knowingly employ or contract with an illegal alien to perform work under this contract or enter into a contract with a subcontractor that knowingly employs or contracts with an illegal alien. The Contractor represents, warrants, and agrees that it (i) has verified that it does not employ any illegal aliens, through participation in the Basic Pilot Employment Verification Program administered by the Social Security Administration and Department of Homeland Security, or (ii) otherwise will comply with the requirements of CRS 8-17.5-101 (2)(b)(i). The Contractor shall comply with all reasonable requests made in the course of an investigation by the CO Department of Labor and Employment. If the Contractor fails to comply with any requirement of this provision or CRS 8-17.5-101 et seq., the City may terminate this contract for breach and the Contractor shall be liable for actual and consequential damages to the City.

ARTICLE 17 - DISADVANTAGED BUSINESS ENTERPRISES

Disadvantaged business enterprises are afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award. Consultants shall insert this provision in all sub-contracts for any work covered by this Agreement, so that it shall be binding upon each sub-consultant or sub-contractor providing labor or services.

ARTICLE 18 – AUTHORIZATION

Each party represents and warrants that it has the power and ability to enter into this agreement, to grant the rights granted herein, and to perform the duties and obligations described herein.
